It is the responsibility of each Participant to check the status of the Event prior to planning his/her travel to the Event.

#### **Risk assessment for COVID-19**

The questions below will enable OCs to review the additional considerations specific to sports, and thus inform their risk assessment of COVID-19 associated with their Event. This will help OCs understand and manage any additional risk from COVID-19.

The risk assessment should be reviewed and reassessed regularly during the planning phase and updated immediately prior to the transition to the operational phase, especially in light of the rapidly evolving nature of the outbreak. Reference should be made to the latest technical guidance and situation reports on the WHO website.

The risk assessment for COVID-19 associated with the Event must be coordinated and integrated with the host country's national risk assessment for COVID-19. The person completing the questionnaire should include input from the local public health authorities, consult WHO's latest technical guidance and ensure that there is an up-to-date evaluation of the epidemiological situation.

# Human and Horses

## Health Measures

#### 1. Introduction

According to current and applicable French regulations, since July 21, 2021, sanitary pass is mandatory for any persons entering the access controlled sport event site.

The sanitary pass consists in

- A proof of vaccination status, or
- A certificate of recovery older than eleven days and less than six months, or
- a negative PCR or antigen test not older than 72 hours before reaching the site.

Children under the age of 18 are exempt from sanitary pass.

Any person feeling unwell with Symptoms of Covid-19, high temperature, fever, and a persistent cough or loss of taste or smell shall NOT attend the event.

### 2. Scope and Purpose

In an effort to mitigate the risk of transmission and further spread of Covid-19, the following policy will be implemented by Castel Competitions Equestres and must be adhered to by ALL individuals attending CCI CHATEAUBRIANT 2021 (September 23<sup>rd</sup> to 26th 2021).

The procedure has been developed in conjunction with the Fédération Française d'Equitation (FFE) guidance, the FEI eventing discipline specific guidelines for FEI eventing events taking place during the Covid-19 pandemic and the applicable French regulations.

This plan will be kept current and relevant and will be updated to reflect current Government guidance. The event policy will not replace the applicable guidance and policies from domestic government and health authorities. It supplements their recommendations with important sport and event specific considerations.

The event is exclusively taking place outside.

This policy also covers veterinary health measures.

#### 3. Role and Responsibility

The OC has designed the following Covid-19 OC Referent: Françoise Després +33 6 07 89 41 48.

Françoise Després is a registered nurse and has direct access to local Covid-19 organisation.

The OC 19 referent is responsible for preparing and overseeing the Covid-19 health measures during the event.

Other responsible individual is the OC Director: Yves Després + 33 6 07 87 22 01

#### 4. Covid-19 Procedure and requirements:

4.1 Event entry, Pre-event collection of information and communication

All Entries will be online and must be complete and paid for.

Entry fees will be paid on line via FFE.compet for French riders and via bank transfer for foreign riders.

A google form with information needed by the OC will be made available for completion by riders, thus reducing the need for additional interaction in the show office.

A website and facebook pages are providing practical and logistical information in particular how to access the google form.

4.2 Mandatory conditions to access the event: Pass sanitary check

All individuals - riders, grooms, officials, volunteers, horse owners, public accessing the access control event site will have to present a sanitary check as defined in section 1.

The OC will implement a check at the site entrance and will provide a colored coded wristband accordingly.

All persons on the event site must adhere to current guidance and advice on social distancing measures which can be found in detail @ <a href="https://www.gouvernement.fr/info-coronavirus">https://www.gouvernement.fr/info-coronavirus</a>.

Antigenic testing will be provided on site at defined period during the event to confirm the access to the event.

#### 4.3 Venue access and circulation

- 4.3.1 The site will have 1 unique entry point.
- 4.3.2 After sanitary check as per 4.2, on-going site control will be done through wristband check.
- 4.3.3 Separate parking with a minimum distance of 2 meters between vehicles for 1)

  Lorry park, 2) Volunteer and Officials, OC, service providers 3) Public car park will be
- 4.3.4 Access to stables will be limited to riders, grooms and owners with access control wristband.
- 4.3.5 Briefing of officials, fence judges and volunteers will be held outside and wearing mask will be recommended. In case of bad weathers (heavy raining), an open tent without panel will be used.
- 4.4 Sanitizing and Personal protective measures:

- 4.4.1 Hand sanitizer and PPE (Personal Protective Equipment) will provide all Officials, warm-up & arena crew, show office staff (masks) and maintenance staff (masks; masks and gloves for staff in charge of cleaning),
- 4.4.2 All persons on site must adhere to the social distancing protocols and keep a minimum distance of 1m from all other participants. If for whatever reason the 1m social distancing guideline has to be broken a mask should be worn. This rule excludes an athlete sitting on a horse.
- 4.4.3 Hand sanitisation stations with access to soap and water or alcohol based hand sanitizer will be provided in toilets and show office. All toilets will be thoroughly cleaned overnight. Hand washing or sanitizer will be available.
- 4.4.4 Competitors are encouraged to use facilities in their own lorry where possible, toilets and showers provided by the OC will be cleaned periodically.
- 4.4.5 Refreshment and Saddlery/Equine trade stands will be present on venue employing strict social distancing measures.

#### 4.5 Time schedule/scoring

- 4.5.1 All scoring, starting lists, results will be <a href="https://dashboard.horses-and-competitions.com/fr/concours">https://dashboard.horses-and-competitions.com/fr/concours</a>
- 4.5.2 At arrival, riders will get their competitor and numbers for cross country and a cross country course map will be provided individually.

#### 4.6 Owners

- 4.6.1 Owners will go through the applicable sanitary pass check and will bear the required wristband.
- 4.6.2 There will be a separate Car Park for Owners near the stables. No cars allowed in the lorry car park.

#### 4.7 Officials & Volunteers:

- 4.7.1 All pre event information detailing protocols and procedures must be read and understood prior to arrival.
- 4.7.2 Separate parking will be available for officials.
- 4.7.3 For those roles where it is difficult to social distance, masks will be provided. It is advised that others who wish to wear do so.
- 4.7.4 We will be operating with minimal contact. Scoring will be done via radios and paper copies will be collected at the end of each test day in case of any issues..

#### 4.7.5 Catering

- 4.7.5.1 Meals will be taken at the dedicated Officials tent and a very limited number of volunteers will access this tent.
- 4.7.5.2 Most volunteers will be on the cross country on Saturday and Sunday will be get a bag with their meal and will eat and drink at their fences.

- 4.7.5.3 Volunteers are asked to respect a physical distancing of 1m and to wear a mask when interfering with Officials and riders.
- 4.7.5.4 Single use plates and glasses will be used.
- 4.7.5.5 Tables, benches, chairs and meals distribution will be thoroughly cleaned.
- 4.7.5.6 The OC is not in charge of volunteers accommodation during the event.

#### 4.8 Contractors

- 4.8.1.1 Contractors will go through the applicable sanitary pass check and will wear the required colored coded wristband.
- 4.8.1.2 The contractors must comply with detailed site rules and work with the site manager at all times.
- 4.9 Horse inspection, warm-up and Competition areas

Stewards will ensure steady flow of athletes and horses to the horse inspection, warm-up and competition arenas without excessive queuing/crowding and observing a one-way system in and out of the horse inspection, holding box and arenas if necessary; preventing also non-essential personnel from congregating in entrance and exit.

#### 4.9.1 Dressage Phase

- 4.9.1.1 Groom/connection to be kept to a minimum and to maintain social distancing at all times
- 4.9.1.2 At each rotation of the judges/scribes, the table, chairs and all materials should be carefully cleaned with a sanitizing solution.

#### 4.9.2 Show Jumping Phase

- 4.9.2.1 Only 1 groom/connection/coach will be allowed to raise practice fences.
- 4.9.3 Cross Country Phase
- 4.9.4 Athletes & Officials will be reminded to respect social distancing during course walks.
- 4.9.5 Fence judges, builders, stewards, fence repair team and course volunteers will be equipped with relevant PPE and individual cleaned charts, radios, pens.
- 4.9.6 Fence judge equipment will be made available before start at each fence.
- 4.9.7 Only 1 person per horse in addition to athlete will be allowed to attend start.
- 4.9.8 OC/TD will ensure that specific start times be respected and ensure interval start times avoid overcrowding in Cross Country warm-up.

#### 4.10 Treatment of Covid-19 case(s) on site

4.10.1 For any case(s) declared the OC Castel Competitions Equestres must be immediately informed.

4.10.2 A crisis Covid-19 team under the coordination of the Covid-19 referent is present on site, in close liaison with COVID-19 reporting organization.

#### 4.10.3 Symptomatic cases

- 4.10.3.1 Riders, grooms or kins: immediate return to rider's lorry, or if not possible isolation in the isolation room at racetrack on site for the purpose.
- 4.10.3.2 Visitors: ask to leave the venue immediately or if not possible isolation in the isolation room at racetrack for the purpose.
- 4.10.3.3 Communication of declared cases: As soon as the family or the person has confirmation of the case, the OC Castel Competitions Equestres must be informed, information to people who might have been in contact.

#### 4.11 Non -compliance - Violation of rules

- 4.11.1 Anyone who does not comply to the sanitary measures will be asked to leave the site.
- 4.11.2 Any excluded competitors cannot ask for reimbursement.

#### 5. Veterinary checks

- 5.1 Pre-Horse Inspection vet and passport check on arrival before entering the stable area.
  - All Passports will be checked at the arrival by the FEI Vet Delegate.
  - All official protests are managed in the Show Office as per FEI rules details of who
    and how to contact the correct official can be found on the notice board at the Show
    Office.
  - All queries and objections will need to be communicated to officials before the competition has concluded whilst volunteers and judges are still on venue or at the latest by 20 hrs. on the day of competition relating to the score.

#### 5.2 Biosecurity plan

#### 5.2.1 Self declaration

- Athlete/Groom to provide a signed FEI self-certification of health status for all of their horses on the event venue, including mandatory temperature monitoring charts for the 10 days leading up to the event.
- This applies to all horses on site, including non-competing horses.
- Please use FEIhorseapp

#### 5.2.2. Temperature taking

- Temperatures of horses must be taken twice daily (morning/evening) by athlete/groom and recorded on the FEI HORSE APP.
- Should any horse display a temperature over  $38,5^{\circ}C$ , the Person Recording must immediately refer to the veterinary officials.

- FEI Officials will check results twice daily.
- Sanctions for non-compliance.
- This applies to all horses on site, including non-competing horses.

#### III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.



#### 2. HEALTH REQUIREMENTS

#### **GENERAL**

In accordance with the FEI Code of Conduct for the Welfare of the Horse it is imperative that all Horses at FEI Events are physically fit and free from infectious disease before being allowed to compete.

#### 3. NATIONAL REQUIREMENTS

#### 4. PONIES

FEI Veterinary Regulations, Chapter IX: For all Pony Events, Ponies must be available for Pony Measurement if requested by the FEI.



#### 5. INJURY SURVEILLANCE

FEI Veterinary Regulations Chapter VIII: Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

#### 6. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in suitable vehicles for the transport of horses. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

#### 7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE

#### 7.1 PASSPORTS (FEI GENERAL REGULATIONS ARTICLE 137)

For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation. All Horses competing at FEI Events must be registered with the FEI.FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events. NB: Horses entered in CIMs and in CSIP in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs 137.2). Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations and may not be allowed to compete. NB: for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

#### 7.2 VACCINATIONS - EQUINE INFLUENZA (FEI VETERINARY REGULATIONS ARTICLE 1003)

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

Vaccination	Protocol	Eligibility to enter venue
Primary course	1st Vaccination: day 0 2nd Vaccination: day 21-92	May compete 7 days after the 2nd Vaccination
First booster	Within 7 months of the 2nd vaccination of the Primary Course	May compete for 6 months +21 days after the 2nd vaccination of the Primary Course Must not compete in the 7 days after receiving a vaccination
Boosters	MINIMUM: within one year of previous booster vaccination IF COMPETING: must be in the 6 months +21 days of the booster previous vaccination	Must have been vaccinated within 6 months +21 days before arriving at the Event Must not compete in the 7 days after receiving a vaccination

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine



Influenza vaccines within the relevant territory.

#### 7.3 EXAMINATION ON ARRIVAL (FEI VETERINARY REGULATIONS ARTICLE 1031)

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

#### 7.4 HORSE INSPECTIONS (FEI VETERINARY REGULATIONS ARTICLES 1034-1042)

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

#### 7.5 LIMB SENSITIVITY EXAMINATION (FEI VETERINARY REGULATIONS ARTICLE 1048-1053)

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event, including, but not limited to, between rounds and before the Jump Off. Horses may be examined once or on multiple occasions during the Period of an Event. Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

#### 8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP)

#### 8.1 SAMPLING (FEI VETERINARY REGULATIONS CHAPTER VII)

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

#### 8.2 ELECTIVE TESTING (FEI VETERINARY REGULATIONS ARTICLES 1057 AND 1058)

Elective Testing may be carried out prior to an Event to check for the presence of prohibited substances. Please refer to https://inside.fei.org/fei/cleansport/horses for information and details.

#### XIII. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

#### XIV. ADDITIONAL INFORMATION

#### 1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") (https://inside.fei.org/fei/covid-19/return-to-play/policy-tools) is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, <u>at the latest ten (10) working days before the event's deadline for Definite Entries</u>.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

#### ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

- Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
- 3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
- 4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

#### 2. MEDICAL INFORMATION FORM FOR ARMBANDS

Declaration of medical condition

Athletes with medical conditions that may be relevant in the case of a medical emergency are responsible, at every Event when riding, for wearing a medical data carrier\* from a system provider able to communicate information at least in English. Alternatively (and at the minimum) a medical armband of good quality can be used. Athletes who chose to wear an armband should download and fill the form available for this purpose on the FEI's website http://inside.fei.org/fei/your-role/officials/eventing/forms.

\* Medical data carrier (also called "medical identification tag"): small emblem or tag worn on a bracelet, neck chain, or on the clothing, intended to alert paramedics/physicians/ first responders that the wearer has an important medical condition.

Conditions that are relevant include recent head injury, serious past injuries/surgery, chronic health problems such as diabetes, long-term medications and allergies. If in doubt, the athlete should discuss this with his own treating physician."



#### 3. INSURANCES AND NATIONAL REQUIREMENTS

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

#### 3.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

#### 3.1.1 Personal accident and health insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses, which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

#### 3.1.2 Press equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

#### 3.1.3 Personal property insurance

You should also ensure that you are insured against property loss, theft or damage, which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place, which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

#### 3.2 ATHLETES AND OWNERS

#### 3.2.1 Third party liability insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

#### 3.2.2 Additional liability information

#### 3.2.3 Horse insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain



while participating at a FEI Event.

#### 4. PROTESTS / APPEALS

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

#### 6. MODIFICATION TO SCHEDULE

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

#### 9. PRIZE MONEY DISTRIBUTION

#### **IMPORTANT**

The total amount of prize money shown for each Competition in the schedule must be distributed. (FEI General Regulations articles 127 and 128)

The value of the 1st prize must not exceed 1/3 of the total prize money distributed for the competition. The minimum number of prizes offered for each competition must be allocated on the basis of one prize for every commenced four Athletes, with a minimum of five prizes.

Full details of any deductions from prize money must be outlined in the schedule. This includes government taxes. If it is necessary for Organisers to deduct such taxes, they must provide participants with an official form indicating the amount of tax deducted.

The tax form must be provided to the athletes upon arrival and returned to the Organiser prior to departing.

#### **XV. ANNEXES**

#### 1. STEWARDING

If an athlete is uncertain as to whether the boots he/she intends to use during an event are allowed, he/she or his/her representative should show the boots to the Chief Steward for his/her opinion before the boots are used in training or in competition.

In addition, athletes are to be made aware that hind boots must be removed and placed again on the horse's legs in the presence of a Steward while in the warm-up arena prior to entering the competition arena for certain competitions. (If bandages are used in place of boots, athletes are not required to remove the bandages in the warm-up arena.) This procedure is compulsory for competitions for which boot and bandage control is mandatory, that is the Nations Cup, Championships, and the competition with the highest prize money, and is at the discretion of the Chief Steward for other competitions.

As an alternative to carrying out this procedure at the time designated by the Steward an athlete may ask his/her groom to take the boots to the in-gate and place them on the horse's legs in front of the Steward prior to the combination entering the arena.

The Steward has the authority to intervene if a boot is deemed excessively tight by instructing that the boot be removed and put on again correctly. [Stewards are to note that it is normal for a horse's gait to be somewhat affected immediately after boots have been removed and re-placed.] If an athlete or his/her groom refuses to remove and re-place the boot(s) when instructed to do so by the Steward, a Yellow Warning Card will be issued to the athlete in question.

If it is deemed impossible or unsafe to remove the hind boots in the warm-up arena prior to the combination entering the competition arena, due to an extremely excited or nervous horse, the boots of the horse in question are to be removed by the athlete/groom following the athlete's round upon leaving the arena and inspected by the Steward. This inspection may be carried out during the boot and bandage control if the boot and bandage control is carried out for the competition in question.

This procedure does not replace boot and bandage control after completion of an athlete's round for competitions for which boot and bandage control is mandatory (refer to JRs Art. 244.1)
